**Terms & Conditions**

1. Qualification & experience are as per ICMR guidelines; experience shall be counted after acquiring the essential qualification; age limit and experience will be considered as on closing date.
2. The application duly signed by the applicant should be submitted along with self attested copies of the certificates. (a) Proof of Date of Birth (b) Educational Qualification (c) Experience (d) Recent Passport size photograph. Unsigned/ incomplete applications or applications without supportive evidence shall be summarily rejected.
3. Benefits of Provident Fund, CCA, Leave Travel Concession, Medical Claim, Earned Leave, Leave Concession etc. are not admissible; since the post is purely temporary, ad-hoc and co-terminate with the project, the incumbents selected will have no claim for regular appointments / employment under ROHC (E)/ NIOH/ICMR or continuation in any other project.

4. Age concession to the extent of service rendered in other research projects will also be admissible for experienced and skilled persons.
5. No TA/DA will be paid for attending the walk-in-interview / written test.
6. Candidates employed in Govt. Service /Semi Govt./Autonomous Bodies of State/Central Govt. should submit a "No Objection Certificate" from their employer at the time of walk-in-interview / written test.
7. As per ICMR guidelines selection of candidate shall be made by walk-in-interview if number of eligible candidates are 30 or less and written test followed by walk-in-interview if number of candidates are more than 30. The written test shall be of one (1) hour duration consisting of objective type questions on General Science, General Analytical Ability and knowledge of concerned area.
